Ordinance No. 2023-44: An Ordinance Amending Section 105.08(p) Pertaining to Fees for Certificates of Occupancy for Residential Rental Units, and Declaring an Emergency. **Adopted 5 - 0**

Resolution No. 2023-45: A Resolution Authorizing the Mayor to Apply for a Community Development Block Grant and Supplement County Grant Program. **Adopted 5 - 0**
