## ORDINANCE NO. 2024-52

AN ORDINANCE DECLARING SURPLUS PROPERTY AND AUTHORIZING THE MAYOR TO DISPOSE OF THE SURPLUS PROPERTY, AND DECLARING AN EMERGENCY.

WHEREAS, The Village Police Department has accumulated various abandoned and/or forfeited surplus property as more fully identified in Exhibit A attached hereto and incorporated herein by reference, and this property is no longer of any value for the Village, and

WHEREAS, ORC 2981.12 requires that the Police Department make application to the local municipal court to obtain a court order authorizing the disposal and/or sale, where appropriate, of certain surplus property in the possession of the Police Department, and

WHEREAS, The Mayor has requested that Council declare the property identified in Exhibit A as surplus property having no value to the Village and to authorize seeking a court order for its proper sale or disposal, and

WHEREAS, Council desires to declare the property as surplus property and to authorize the Mayor to dispose of the property in the Mayor's discretion by sale or gift or destruction as specified below.

## NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF HIGHLAND HILLS, OHIO:

<u>Section 1:</u> That the property more fully described in Exhibit A, attached hereto and incorporated herein fully by reference, is hereby declared to be surplus property having no appreciable value to the Village.

<u>Section 2</u>: The Law Director is hereby authorized and directed to make application to the Bedford Municipal Court for an order pursuant to ORC 2981.12 authorizing the proper disposal of the surplus property including where permitted, the sale of said property.

<u>Section 3:</u> Upon approval of the Bedford Municipal Court, the Mayor is authorized to enter and execute any necessary agreements for the sale, transfer or disposal of the surplus property in a manner that meets the requirements of the Court, the Ohio Revised Code, Finance Director and Law

Director. Further, if there is an attempt to auction any of the items and if that method fails, then the Mayor is hereby authorized to dispose of the property by other means including direct sale, destruction, transfer for value (barter - only with another government entity) in the Mayor's discretion with the proceeds of any sale or transfer being deposited in a fund at the discretion of the Finance Director for the benefit of the Police Department.

<u>Section 4:</u> Council finds and determines that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an orderly meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were conducted in meetings open to the public and in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 5: This Ordinance is declared to be an emergency measure necessary to provide for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the Village of Highland Hills and for the orderly operation of the Police Department, and provided it receives the affirmative vote of two-thirds (2/3) of all members elected to Council, it shall take effect and be in force immediately upon its passage, otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
