<u>Section 2:</u> That there be and is hereby levied on the tax duplicate of said Village the rate of each tax necessary to be levied within and without the ten mill limitation hereby attached and incorporated herein by reference as Schedule A and Schedule B.

<u>Section 3:</u> That the Clerk of this Council be and hereby is directed to certify a copy of this Resolution to the Cuyahoga County Fiscal Officer.

<u>Section 4:</u> Council finds and determines that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an orderly meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were conducted in meetings open to the public and in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
