A RESOLUTION ACCEPTING THE AMOUNTS AND RATES AS DETERMINED BY THE BUDGET COMMISSION OF CUYAHOGA COUNTY AND AUTHORIZING THE NECESSARY TAX LEVIES, AND CERTIFYING THEM TO THE CUYAHOGA COUNTY AUDITOR.

WHEREAS, this Council, in accordance with its Charter and statutory provisions, has previously adopted a tax budget for the next succeeding fiscal year commencing January 1, 2025, and

WHEREAS, the Budget Commission of Cuyahoga County, Ohio, has certified its action thereon to this Council together with an estimate by the Cuyahoga County Fiscal Officer of the rate of each tax necessary to be levied by this Council, and what part thereof is without and what part is within the ten mill tax limitation.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF HIGHLAND HILLS, OHIO:

Section 1: That the amounts and rates, as determined by the Cuyahoga County Budget Commission, in its certification, be and the same are hereby accepted.

Section 2: That there be and is hereby levied on the tax duplicate of said Village the rate of each tax necessary to be levied within and without the ten mill limitation hereby attached and incorporated herein by reference as Schedule A and Schedule B.

Section 3: That the Clerk of this Council be and hereby is directed to certify a copy of this Resolution to the Cuyahoga County Fiscal Officer.

Section 4: Council finds and determines that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an orderly meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were conducted in meetings open to the public and in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.


