A RESOLUTION CONFIRMING COUNCIL'S APPOINTMENTS TO THE CHARTER REVIEW COMMISSION FOR 2024-2025, AND DECLARING AN EMERGENCY.

WHEREAS, Article Nine, Section Seven of the Highland Hills Charter authorizes Council to appoint three (3) people to the Charter Review Commission commencing in November 2024, and

WHEREAS, the Council has appointed Jacqueline Lark, Kenneth Troutman and Diane Griggs to serve on the Charter Review Commission for 2024-2025, and

WHEREAS, Council desires to keep an accurate record of these various appointments.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF HIGHLAND HILLS, OHIO:

<u>Section 1:</u> That Council hereby approves the appointments of **Jacqueline Lark, Kenneth Troutman and Diane Griggs** to the Charter Review Commission.

Section 2: That said appointments shall be effective upon taking said oath of office.

<u>Section 3</u>: Council finds and determines that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an orderly meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were conducted in meetings open to the public and in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4: This Resolution is declared to be an emergency measure necessary to provide for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the Village of Highland Hills and for the reason that it is necessary to immediately approve these appointments to allow the members to meet in a timely manner as required by the Charter, and provided it receives the affirmative vote of two-thirds (2/3) of all members elected to Council, it shall take effect and be in force immediately upon its passage, otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
