# From the Desk of Council President Lillian R. Moore

Greetings to the residents of Highland Hills!!!

As a councilmember for this Village, I attended the National League of Cities 2015 NBC-LEO summer conference which was held in Miramar, Florida. The conference provided several sessions of interest, one of which I felt was important to our Village residents. The session of most importance was the "The Need to Develop & Implement Equitable Energy Policies," presented by Representative Joe Gibbons of Florida, who now is the Chairman of the National Black Caucus of State Legislators Committee on Energy, Transportation, and Environment. Mr. Gibbons went into detail explaining the need to be educated on affordable and reliable access to basic energy, with clear understanding on the installation of solar panels.

The idea of solar panels for the Shaker House was introduced by Councilwoman Leah Lewis, who had done extensive research to show the impact and benefits of solar panels.

The Business Section of *The Plain Dealer* dated Sunday, August 9<sup>th</sup> 2015, featured an article entitled "New deep-discount program looks to solarize Cleveland." The article gives information and history on companies in the greater Cleveland area who are now installing solar panels on homes, along with the cost of installation, benefits and use on how to it make affordable when considering a solar panel array for the roof of your home.

This article explains advantages of installing solar arrays on rooftops. The benefits of solar arrays are estimated to reduce your monthly utility bill by 50%, while generating extra solar energy that can be stored and/or sold back to the supplier. The cost of solar panels and installation is expensive. Some contractors are promoting hefty contracts for a 20-year unbreakable term in the amount of \$15,000 or more. With today's technology, these solar panels will be outdated within five (5) years.

In summary, should you decide to install solar panels, it is very important to know the terms of your contract, and the non-transferrable fees which apply if you decide to sell your home. Please research the solar panel installation contract thoroughly and beware that the solar panels are not free, nor is the installation and/or their removal.

#### PAPER SHREDDING EVENT

Outsourcing our shredding is more secure and less expensive than shredding it ourselves. So, Council decided to encourage our community to come out with their paper materials to be

shredded. On Saturday June 20, 2015 Council sponsored the **Community Shredding Event** that was located at the Fire Station. It was a free event to provide our residents peace of mind knowing that their confidential documents are securely 100% properly destroyed and recycled. As residents and others brought their paper items each person could watch the process and know that their paper products destruction was completed. This first time event was successful. Thirty (30) residents came out and shredded 3,179 pounds of paper products. Thanks was given to Fire Chief Timmons, and some firemen for helping to direct traffic and thanks to our Public Works Director, Steve Clymer for providing enter and exit signs. Let your Council members know if you would like another shredding day next year.

#### SAFETY COMMITTEE REPORT

As the Chairperson of the Safety Committee, I want our community to know that Council is receiving monthly total Fire Department and Police Department information. Fire Chief Timmons provides medical and fire calls such as: fire alarms, medical transports, called off en route or upon arrival, structure fire (mutual aid given), public service and smoke ordor. In the Police Department, Sergeant Koran provides statistics such as: traffic citations, traffic arrests, misc. traffic, criminal arrests, officer activity and officer/community engagement. At the end of year 2015 Council will have information on the services that these two departments provide and we will have a good assessment of numbers of activities taking place in Highland Hills. Council thanks both departments for providing security for the people of Highland Hills.

### From the Desk of Councilwoman Leah Lewis



For the first time, the Village of Highland Hills Council conducted a series of meetings with residents in the various segments of our COMMUNITY. After receiving numerous complaints from tenants seeking assistance, we purposed the first meeting to hear from residents so as to present their concerns to the Mayor, who is responsible for administration of the building and its management. I was fortunate to chair two meetings of the tenants of the Shaker House on March 25,

2015 and April 28, 2015. Over 30 residents of the Shaker House attended the first meeting.

Council President Lillian Moore and I met with the Mayor's office twice to stimulate positive changes for the Shaker House residents regarding their quality of life and maintenance and upkeep of the building, particularly the residential portion. Our second meeting with residents offered a follow-up from our initial meeting with the Mayor's office. Additionally, we presented Angela Shuckahosee, Director of the Cleveland Tenants' Association, who spoke on Tenant's Rights and Management Responsibility.

As members of Council, Council President Moore, Councilwoman Barbara Spearman, Councilwoman Nicole Young and I live on purpose. Our purpose is to SERVE you – our constituents – for together, we comprise the Village of Highland Hills. For us, nothing – not petty politics, not personal conflicts, nor unfortunate acts of misdirection and misinformation intended to mislead you or hinder our effectiveness – stands in the way of putting our constituents first! Without you, we have no advocacy, legislative or governmental purpose. On this, we are clear.

To this end, we fully expect to continue to meet with residents from time-to-time throughout the calendar year. # **NOVEMBER 3, 2015 GENERAL ELECTION**

On **Tuesday, November 3, 2015**, Highland Hills residents will have an opportunity to cast their votes for Mayor and four Members of Council, in addition to a number of issues. For your information, below are the issues you can expect to see on the ballot:

<u>Issue 57 - Proposed Tax Levy (Renewal)</u> – A renewal of a tax for the benefit of the Village of Highland Hills for the purpose of current expenses at a rate not exceeding 6 mills for each one dollar of valuation, which amounts to 60 cents for each one hundred dollars of valuation, for five years, commencing in 2015, first due in calendar year 2016.

<u>Issue 58 - Proposed Ordinance (Electric Aggregation)</u> – Shall the Village of Highland Hills have the authority to aggregate the retail electric loads located in the Village of Highland Hills, and for that purpose, enter into service agreements to facilitate for those loads the sale and purchase of electricity, such aggregation to occur automatically except where any person elects to opt out?

<u>Issue 59 - Proposed Charter Amendment</u> – Shall Article II, Section 1 and Article III, Section 4 of the Charter of the Village of Highland Hills be amended to reduce the number of councilpersons from six (6) to five (5), and remove the Mayor's power to break a tie vote of council?

<u>Issue 60 - Proposed Charter Amendment</u> – Shall Article III, Section 6, the Mayor's Estimate, be repealed and those duties added to amend Article VII, Section 3, Finance Director Duties, requiring the Finance Director to produce specific financial reports?

<u>Issue 61 - Proposed Charter Amendment</u> – Shall Article VI, Section 3 of the Charter of the Village of Highland Hills regarding recall elections be amended to remove the paragraph and reference regarding the Clerk-Treasurer, which position was previously repealed?

<u>Issue 62 - Proposed Charter Amendment</u> – Shall Article IX of the Charter of the Village of Highland Hills be amended to add Section 10 to create a Strategic Plan Commission to require the creation of and approval of a strategic plan every five (5) years?

<u>Issue 63 - Proposed Charter Amendment</u> – Shall the Charter of the Village of Highland Hills be amended to provide for the repeal of Article X, Section 3 Abolition of Offices, to remove reference to the Clerk-Treasurer which position was previously repealed?

The Village has also begun collecting batteries (regular batteries - no car batteries), so feel free to bring those used batteries up to Village Hall to be recycled.

#### SPOTLIGHT ON RESIDENT H. DA VINCI BULLOCK, SR.

Born in Granville County, North Carolina, H. DaVinci Bullock, Sr. was given the name "DaVinci" by his college art professors to replace the middle initial "D." He received both B.S. and Master's Degrees from North Carolina A & T State University in Greensboro, North Carolina.

Mr. Bullock has been a serious painter since graduation from college in 1948. His works depict scenes from a variety of subject matter ranging from sea and landscapes to portraits and historical compositions. He has exhibited watercolors, acrylics, oils and ink drawings with much success all over the country. 

For your information, below is a map depicting the traffic patterns with the ongoing construction on Northfield and Warrensville Roads. As you know, Northfield Road has been permanently closed at Chagrin. Traffic is not able to travel north or southbound through the intersection of Warrensville and Chagrin Boulevard. South of the intersection, Northfield now dead ends into a new cul-de-sac. Local access to buildings between the intersection and the Northfield Road roundabout is from the south only (or from Warrensville).
