

Village of Highland Hills, Ohio  
Performance Bond (HHCO §1329.02)

That, \_\_\_\_\_, as Principal, (“CONTRACTOR”), and \_\_\_\_\_, as Surety, (“SURETY”), are held and bound unto the Village of Highland Hills, (“VILLAGE OF HIGHLAND HILLS”), for the benefit of any person, firm, or corporation with whom the CONTRACTOR contracts and who suffer damage as a result of a breach or residential or commercial construction or remodeling contract through work done or work omitted or not performed by CONTRACTOR, for any and all improvements, in accordance with the laws and regulations of the State of Ohio and of THE VILLAGE OF HIGHLAND HILLS, in the amount of \$25,000, for the payment of which we, CONTRACTOR and SURETY, bind ourselves, our heirs, executors, administrators, successors, and assigns, jointly and severally.

This bond is payable for damage sustained on account of the failure of CONTRACTOR to perform such contracted improvements in accordance with the laws of the State of Ohio, (“OHIO”), and the provisions and the requirements of the Rules, Regulations, Laws, and Ordinances of THE VILLAGE OF HIGHLAND HILLS, or by reason of or on account of such failure of CONTRACTOR pursuant to any permit issued by THE VILLAGE OF HIGHLAND HILLS under such Certificate of Registration for such contracted improvements.

The conditions of the above obligation are such that, CONTRACTOR has applied to the Building Commissioner of THE VILLAGE OF HIGHLAND HILLS for a Certificate of Registration as a \_\_\_\_\_ Contractor in THE VILLAGE OF HIGHLAND HILLS for the year ending December 31, \_\_\_\_\_.

Now, therefore, if CONTRACTOR shall faithfully perform the duties and in all things comply with the laws and regulations of OHIO and THE VILLAGE OF HIGHLAND HILLS, including all amendments thereto, pertaining to the license or permit applied for, then this obligation is void, otherwise to remain in full force and effect.
